Subject : Central plan Scheme-Implementation of the scheme for Area Intensive and Madarsa Modernisation Programme- Release of Central Grant in aid (recurring) during the year 2004-05, 2005-06 and 2006-07 to the State Government of Uttar Pradesh.

Sir,

I am directed refer to the Government of Uttar Pradesh proposal dated 19.10.2007 for salary of 953 middle level teachers (recurring) in 1616 new Madrasas under the scheme of Area Intensive and Madarsa Modernization Programme during the years 2004-05, 2005-06 and 2006-2007, amounting to Rs.13.49 crores.

2. In continuation of this Ministry's sanction of even number dated 30.3.2007 I am directed to convey the sanction of the President to release Rs.10,18,91,000/- (Rupees Ten crores eighteen lakhs and ninety one thousand only) as the final instalment to the Secretary (Minority Welfare & Wakf) Government of Uttar Pradesh, Lucknow, for the years 2004-05, 2005-2006 and 2006-2007 as recurring grant for implementation of the above mentioned scheme, subject to fulfilling all the terms and conditions laid down in the scheme in terms of this Ministry's letter dated 31.12.93. This is a purely voluntary scheme and the concerned institution has to apply to the State Government for assistance.


3. The State Government is requested to ensure that the Madarasas are in existence for three years and the teachers for whom the salary is paid through this grant were actually in position during the period. A certificate to the effect that the Madarasas are in existence, the teachers are in position, have taught modern subjects in the Madarasas, have been paid their salaries and required budget provisions were made in the state budget in the years may please be furnished to this Ministry.

4. The expenditure involved is debitable to Demand No. 57-Department of Higher Education - Major Head '3601' - Grants in aid to State Govts - 03- Grants for Central Plan Scheme - 171 - General Education Other Grants - 02 - Area Intensive and Madarsa Modernisation Programme - 02.00.31 - Grants in aid (Plan) 2007-2008.

5. It is certified that the grant in aid is being released in accordance with the pattern of assistance approved by the Ministry of Finance and in conformity with the rules and regulations governing the scheme.

6. The grant-in-aid, is subject to adjustment later on receipt of the audited counts from the State Government to be furnished to the Central Government latest by 31st March, 2008 positively along with the physical achievement and monitoring reports.
7. On receipt of the sanction letter, the Principal Accounts Officer may issue an advice to Reserve Bank of India (Central Accounts Section), Nagpur to credit to the account of the State Government. The Principal Accounts Officer may forward a copy of the advice to the Accountant General and Finance Department of State Government concerned alongwith a copy to the undersigned.
8. This issues in exercise of the delegated powers in consultation with the Integrated Finance Division's vide their Dy.No.3135/IFD dated 1.6.2007 and Integrated Finance I vide Dy. No.914-0/07-IF-1 dated 13.06.2007.
