NOTIFICATION


Whereas "**Kerala Kalamandalam, Thrissur, Kerala** was declared deemed to be a university under Section 3 of the University Grants Commission (UGC) Act, 1956 vide this Ministry's notification of even number dated the 14th March, 2006 subject to certain conditions including the one that pertained to '**granting of the UGC's pay scales to its employees with effect from the date of submission of application for 'deemed to be university' status**';

2. And whereas, the State Government requested the Central Government to do away with the clause of condition referred to in para 1 above and expressed its readiness to pay the UGC's pay scale to the eligible employees instead from the beginning of the current academic year, i.e. from the effective date of functioning of the 'deemed-to-be-university' institution;

3. And whereas, the said request of the State Government of Kerala was forwarded to the UGC for examination. Upon consideration of the request, the Commission have now conveyed their 'No Objection' to the deletion of the clause of condition in question and to replace it with a clause of condition to allow the Kerala Kalamandalam to grant UGC's pay scale to its employees with effect from the date of notification of 'deemed to be university' status;

4. Now, therefore, the Central Government, on considering the request of the State Government of Kerala and the advice of the UGC in the matter, and in exercise of the powers conferred by Section 3 of the UGC Act, 1956, do hereby delete the clause of condition of this Ministry's Notification of even number dated the 14.03.2006 referred to in para 1 above and substitute the same with a modified clause of condition which shall read as "**granting of the UGC's pay scales to its employees with effect from the date of this Notification**".

5. The other conditions that govern the declaration made in the Ministry's Notification of even number dated the 14.03.2006 shall remain unaltered.
