Subject:- Revision of pension structure of the teachers who retired prior to 1.1.2006 – representation of the All India Federation of Retired University and College Teachers' Association – regarding.


Sir,

I am directed to say that in pursuance of the recommendations of the 6th Central Pay Commission, the Central Government revised the pension structure of the Central Government employees with effect from 1.1.2006 vide Department of Pension and Pensioners' Welfare O.M. No. F. No. 38/37/08-P&PW(A) dated 1.9.2008. Subsequently, this Ministry has issued clarifications vide its letter of even number dated 15.12.2009 regarding revision of pension of pre-2006 pensioners/family pensioners who retired as Readers/Lecturers (Selection Grade) and equivalent cadres; and Deputy Registrars/equivalent cadres in Central Universities and Colleges.

2. The All India Federation of Retired University and College Teachers' Associations (AIFRUCTA) have represented that the above orders may also be implemented in the State Universities and Colleges. A copy of the representation dated 23.12.2009 is enclosed.

3. State Governments may like to take action as deemed appropriate for the revision of pension of teachers in State Universities and Colleges, who retired prior to 1.1.2006 in the UGC scales of pay and for whom pension structures as applicable to teachers in Central Universities and Colleges apply.

We submit that consequent upon the revision of 6th Central Pay Scales the Government of India in the reference 1st quoted had revised the pension structure w.e.f. 1-1-2006 to the pensioners retired prior to 1-1-2006. Since 6th U.G.C. scales were also revised with effect from 1-1-2006, the pension structure was also extended to the Central Universities with an amendment allowing 50% pension on pay band IV for those who have completed 3 years of service prior to 1-1-2006 in the Selection Grade/Reader Scales under ref.(3). The above orders are yet to be implemented in the State Universities / Colleges.

We therefore request you, Sir, to issue appropriate orders to the States for the implementation of the above orders for those teachers who retired prior to 1-1-2006 in U.G.C. scales of pay.
